## **NUUC Board of Trustees Meeting**

October 17, 2024

## 1.) Check-In

- a. Next meeting, we need to approve August, September, October minutes
- b. We did not have quorum in September to approve August; September minutes were not ready by October meeting
- 2.) Non-Active Member Removal (Kate Rhoad from Membership Circle)
  - a. Kate Rhoad shared the process by which the Membership committee recommends member terminations (see attached document)
  - b. Membership is considering changing bylaws so that removal does not require board approval
  - c. Board feedback: while approval may not be necessary, it's not a bad idea for the board to double-check the list in case they are familiar with a person or situation that needs follow up; board will review monthly updates from stewardship for this purpose
  - d. Board feedback: are their trends noted in why folks are leaving? Answer: not strong trends, but a couple of folks noted they had had losses and did not feel the NUUC community supported them adequately
  - e. Membership is working with stewardship, hoping to move financial contribution/new pledge piece of membership to stewardship, as membership has many duties
- 3.) Treasurer's Report (Jeremy Northum)
  - a. Checking account: \$39,517.37
  - b. Share the Paddle fund: \$4,892.78
  - c. Jeremy proposes we add the Share the Paddle funds as a line item in the budget; each year when we build the budget, we can put in an (low) estimate in the budget and adjust to reflect the actual amount raised
- 4.) Minister's Report (Rev. Sarah)
  - a. Rev. Sarah will take her 4 month sabbatical in the 2025-2026 year
    - i. She will break it into two, two-month sabbaticals
    - ii. We need to budget for the cost of covering a guest minister and possibly have someone on call for emergency pastoral care needs
      - 1. Estimate \$5000
      - 2. Jeremy's suggestion: in the future we should incorporate this expenditure in our budget
  - b. The Woodlands Christian Church is for sale
    - i. \$4.9 million, 300-seat sanctuary
    - ii. This warrants discussion
      - 1. Where is Northwoods headed?
      - 2. Do we want to grow and how?
      - 3. 5 and 10-year plans

- 4. Board questions/concerns: Besides space, what dynamics keep us from growing? How would our energy be diverted from projects going on now, especially projects that are building and clarifying processes?
- 5. Suggestion to have a casual, low stakes meeting one Sunday after church to discuss the idea and our vision
- 5.) Town Hall for Bylaws Revisions
  - a. Town Hall roughly scheduled for late January
  - b. Goal to tag bylaw revision meeting on immediately after the annual meeting
- 6.) Service Auction- Raise the Paddle
  - a. S.A. representatives have expressed hesitation about adopting the project manager plan for RTP
  - b. Board would still like to see a RTP project proposal form completed for each project and a project manager in charge; board members do not feel comfortable approving large expenditures without a chain of command and competitive bids for large purchase
- 7.) Google Drive
  - a. A NUUC Google drive has been launched
  - b. Goal is for it to be a home for church documents so they can be easily shared and accessed by all
